Delhi Programs

Education at Arpana Center

Arpana's Center in Gautampuri, Molar Bund, New Delhi, provides Tuition Support Classes, Nursery classes and Vocational Training to underprivileged children, along with opportunities to participate in cultural activities of Music, Dance and Drama.

<u>CBSE results for Class 12, 2020</u>, was declared on 13th July 2020. All 38 students from Arpana passed successfully, with 36 getting first division.

In Humanities, Vijay Laxmi stood first with 92.4%. In Science, Akash secured 94.8% in aggregate and in Political Science, Lakshika scored 90%.

<u>Felicitations</u> and certificates were given to Class 12 students on 27th July for their excellent results in CBSE examination. The ESSEL Foundation, through its Chairman, Mrs. Reva Nayyar, awarded Rs.5000 each to the top three meritorious students.



Vijay Laxmi, Humanities topper, lives in Gautampuri with her family of 7. Her father is a tea vendor. She attended Arpana's classes from age 3, forming a strong foundation. She received a monthly scholarship of Rs.500 (for books and stationery) from Arpana from Class 8 onwards. With her teachers' guidance and assistance, she has truly excelled. Now she wants to join Delhi University and aspires to be a teacher.

- 2. sit in circles 6 feet apart
- wash their hands, upon entering and while leaving, with the sanitizer and handwash facilities provided.

Ram Niwas is a daily wage worker from village Ballha, Karnal who lives alone as there is no one in his family. After he had experienced blurred vision for two months, his neighbour recommended he come to Arpana Hospital.

Ram Niwas came to the hospital on July 25, and the ophthalmologist advised surgery for cataract in his left eye. But he refused surgery due to financial problems. It was then explained to him that many poor patients are treated free at Arpana Hospital and he would not

be charged for the surgery. After his successful operation, Ram Niwas was very grateful to Arpana for his eyesight and for his excellent care.

Activities Carefully Begun after COVID-19 Restraints



- **OPD Clinic** at Arpana Medical Centre, Bakrota, has been held daily during the lockdown.
- The Gajnoi Centre resumed its rural development activities on 1st July.
- Farmers Groups have started holding field meetings in small numbers following the social distancing norms.
- Tailoring and Craft Classes started in 4 remote Jatkari village centers which opened last March but closed during lockdown. 67 enthusiastic women and girls are learning to stitch ladies suits and baby clothes as well as to knit sweaters, socks, mufflers, in the 45-day training.
